#### 5. Accessibility Award – next steps

Rebecca Hill volunteered to do some research and drafted some nomination questions and criteria for review by the JAAC. This criterion was circulated to the JAAC for review. The group had significant discussion on this issue. Key points include:

- The nomination process is useful, keeps focus in line with AODA Standards and provides more formality of the nomination.
- The group is committed to making the award process friendly and uncomplicated.
- However, a nomination process allows us to keep accurate records of who received recognition for their accessibility efforts.
- An award campaign with a specific timeframe would be easier to market.
- There was some discussion about levels of accessibility to be recognized: Platinum, Gold, Silver Bronze. However, the group felt this would complicate the intention of the award as we'd have to qualify each level.
- We need to reach out to BIA's and Chambers and ads in newspapers, and to all JAAC partners to market this award.
- A number of award names were discussed:
  - Accessibility Pathways Award
  - Accessibility Advancement Award
  - o Accessibility Achievement Award
  - Access Forward Award although Donna mentioned that this is identical to a training business name.
  - Accessibility Matters Award

Rebecca will set up a voting poll so members can vote privately for the award name.

# 6. Town of Lincoln AODA and funding for small businesses resolution

province to establish funding for businesses attempting to comply with the AODA. Further the JAAC believes that this resolution should be shared with other municipalities before being forwarded to the Province. This resolution should be shared as quickly as possible so that affected businesses will be able to comply with the AODA deadline of 2025.
