BY-LAW NO. 4706/88/05

BEING A BY-LAW TO AMEND BY-LAW 3475/56/97, AS AMENDED, BEING A BY-LAW ESTABLISHING PARKING LOTS IN THE CITY OF PORT COLBORNE AND FOR REGULATING, SUPERVISING & GOVERNING THE PARKING OF VEHICLES THEREIN & THEREON & TO PROHIBIT THE PARKING OR LEAVING OF MOTOR VEHICLES, PRIVATE PROPERTY OWNED OR OCCUPIED BY THE CORPORATION OF THE CITY OF PORT COLBORNE OR ANY LOCAL BOARD THEREOF

WHEREAS the Council of the Corporation of the City of Port Colborne enacted By-law 3475/56/97, Being a By-law to Provide for Establishing Parking Lots in the City of Port Colborne and for Regulating, Supervising and Governing the Parking of Vehicles Therein and Thereon, and to Prohibit the Parking or Leaving of Motor Vehicles on Private Property Owned or Occupied by the Corporation of the City of Port Colborne or Any Local Board Thereof, on the 28th day of April 1997;

AND WHEREAS the Council of the Corporation of the City of Port Colborne approved the OPDS-Operational Services Division - Director's Report #2005-44, Parking Lot and Handicapped Parking Amendments, Market Square & 59 Charlotte Street Lot, on the 25th day of July 2005;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF PORT COLBORNE ENACTS AS FOLLOWS:

- 1. That Schedule "A", to Bylaw 3475/56/97, as amended, be amended by adding thereto the following:
 - 11. 59 Charlotte Street Parking Lot
 - 12. Lock 8 Park S.L.S.A. Lease Agreement #661071 & 661162
- That Section 3 General Parking Regulations, to Bylaw 3475/56/97, as amended,
 be further amended by adding thereto the following:
 - 3.4.1 Restricted days and times shall be set out in Schedule "C" to this Bylaw and no person shall park a vehicle or permit a vehicle to remain parked for a longer period of time displayed on official signs.
- 3. That Schedule "C" Restricted Time Limitation be added as follows:
