BY-LAW NO. 5583/13/11

**BEING A BY-LAW TO AMEND BY-LAW 4876/101/06, BEING A BY-LAW TO ESTABLISH A COMMITTEE KNOWN AS THE "PORT COLBORNE WAINFLEET PHYSICIAN RECRUITMENT, RETENTION AND MEDICAL EDUCATION COMMITTEE" AND TO PROVIDE FOR THE APPOINTMENT OF MEMBERS THERETO**

**WHEREAS** the Council of The Corporation of the City of Port Colborne enacted By-law 4876/101/06, Being a by-law to Establish a Committee Known as the "Port Colborne Wainfleet Physician Recruitment, Retention and Medical Education Committee" and to Provide for the Appointment of Members Thereto, on July 24, 2006;

**AND WHEREAS** By-law 4876/101/06 has been amended from time to time;

**AND WHEREAS** the Council of The Corporation of the City of Port Colborne approved the recommendations of the Department of Community & Corporate Services, Clerk's Division, Report No. 2011-8, Subject: Appointments to Boards and Committees, Second Recruitment Effort, on February 28, 2011;

**AND WHEREAS** the Council of The Corporation of the City of Port Colborne received for information correspondence from the Township of Wainfleet regarding the Town's contribution to the Physician Recruitment Program and correspondence from Bea Kenny, Chair, regarding the Township of Wainfleet's Participation in the Physician Recruitment, Retention and Medical Education Program, on June 28, 2010;

**AND WHEREAS** the Township of Wainfleet is no longer a participant of the Physician Recruitment, Retention and Medical Education Committee;

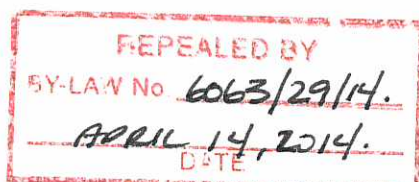
**AND WHEREAS** the Council of The Corporation of the City of Port Colborne is desirous of further amending By-law 4876/101/06 so as to change the name of the Committee to remove reference to the Town of Wainfleet;


**AND WHEREAS** Council is desirous of making appointments to fill vacancies on the Committee due to the expiry of membership terms;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF PORT COLBORNE ENACTS AS FOLLOWS:**

1. That By-law 4876/101/06, Being a by-law to Establish a Committee Known as the "Port Colborne Wainfleet Physician Recruitment, Retention and Medical Education Committee" and to Provide for the Appointment of Members Thereto, enacted on July 24, 2006, be amended by replacing throughout the by-law the words "Port Colborne Wainfleet Physician Recruitment, Retention and Medical Education Committee" with the words "Port Colborne Physician Recruitment, Retention and Medical Education Committee"; and
2. That Peter Opdam be hereby appointed to the Port Colborne Physician Recruitment, Retention and Medical Education Committee for a term ending December 31, 2012;
3. This by-law shall come into force and take effect on the day of its final passing.
